This Supplement (the **Supplement**) to the Offering Circular dated 15 December 2017, (the **Offering Circular**) which comprises a base prospectus constitutes a prospectus supplement for the purposes of Article 16.1 of Directive 2010/73/EU of 24 November 2010 (the **Prospectus Directive**) as amended and Article 13.1 of the Luxembourg act dated 10 July 2005 on prospectuses for securities (the **Prospectus Act 2005**) and is prepared in connection with the €3,000,000,000 Euro Medium Term Note Programme (the **Programme**) established by Avinor AS (the **Issuer**).

Application has been made to the *Commission de Surveillance du Secteur Financier* (the **CSSF**) in Luxembourg for approval of this Supplement in its capacity as competent authority under the Prospectus Act 2005, which implements the Prospectus Directive.
